## INFORMATION NOTE ON THE PROCESSING OF PERSONAL DATA.

KASTEL SRL –Via Friuli 35/37 – 31020 San Vendemiano (TV), email: amministrazione@kastel.it, as the controller of your personal data processing (hereinafter "Data Controller"), issues this information document in compliance with the European and Italian regulations on the protection of personal data. This notice complements the browsing policy of our website, in order to explain to the User how the Data Controller will specifically process the data entered in this contact form. We therefore invite you to read our privacy policy.

Purposes and Legal Basis of treatment

If you subscribe to this service, KASTEL SRL will process the personal data collected to send out the newsletter by email. The newsletter includes information on products and/or services, as well as promotions or invitations to events the Company will attend. The legal basis is the need to pursue such purpose.

**Data Retention Period** 

The Data Controller will process the data for twenty-four months from the last contact, regardless of the channel used. The data subject may withdraw the consent or oppose to the processing at any time.

Nature of the Provision of Data and Consequences of any Refusal

The provision of data is optional, but the refusal to disclose them makes it impossible to subscribe to this service.

**Scope of Data Disclosure and Categories of Recipients** 

The Data Controller will not disclose the data, which will be transferred exclusively to internal figures authorized to process the data according to their respective duties. The same applies to professionals, companies or other third parties who carry out outsourced activities and who are therefore appointed as data controllers with a specific contract or other legal act.

Data Transfer to a Third Country and/or an International Organization

To send the newsletter, the Company uses an external platform, whose servers are located in the United States. Please note that the provider declares to accede to the agreement called Privacy Shield, which the European Commission considers suitable to guarantee appropriate security measures.

Rights of Data Subjects

The Data Subject has the right to unsubscribe from this service at any time and may also ask the Data Controller to access his/her personal data and correct them if they are inaccurate, delete them or limit their processing if the necessary conditions are met, and to obtain their portability.
